SECTION I





THE TOWNSHIP OF THE FORD ORDAINS:

SECTION I

Pursuant to the provisions of Section 9 of Act 230 of the Public Acts of 1972, the Ordinance Enforcement Officer of the Township of Theford is hereby designated as the enforcing agency to discharge the responsibilities of the Township of Theford under Act 230 of the Public Acts of 1972, State of Michigan. The Township of Theford hereby assumes responsibility for the administration and enforcement of said Act throughout its corporate limits.

SECTION II

All Ordinance inconsistent with the provisions of this Ordinance are hereby repealed.

SECTION III

This Ordinance shall become effective September 1, 1984, which is 17 days after its date of publication in the Clio Messenger.

**PREAMBLE**

In recognition of the authority given local units of government by the State Legislature in Act 101 of Public Acts of 1976, the increasing costs incurred by the Township of The Ford for said fire and the civil action obligation to pay the City of Vienna, Fire Authority Two Hundred Fifty-Five and the City of Vienna, Fire Authority One Hundred Fifty-Five for fire protection services, and to set the rates therefor, it is hereby ordained that the rates for fire protection services shall be as follows:
