- Not have similar medical fringe benefits available from a spouse or an employer of a spouse without change to the Participant, and
- Not been terminated for cause; and
- Not been convicted of a crime related to the participants' service with the Township. And

3.3 -- Points are accumulated by an Employee as follows:

- An employee shall be given one point for each year of age
- An employee shall be given one point for each year of continuous full time service.

All other provisions of previous Ordinance 94, adopted 2-9-1998 shall remain effective and are hereby reincorporated into this Ordinance by reference.

#### ORDINANCE NO. <u>2015</u>-06-03

#### THETFORD TOWNSHIP ORDAINS:

#### Article I - Statement of Purpose

1.00<sup>e</sup>The purpose of this Ordinance shall be to establish, pursuant to MCL 41.110b, a medical fringe benefit continuation system which provides for persons who have rendered long and continuous service to the Township of Thetford with continued medical fringe benefits after they terminate their service to the Township of Thetford.

#### Article II - Definitions

2.1 Medical Fringe Benefits – Means the health, medical, hospitalization insurance, dental and vision insurance provided by the Township to a participant.

2.2 Medicare Benefits – Means the medical and hospitalization provided by the United States Government to persons at least 65 years of age.

2.3 Participants – Means an employee, retiree or elected official who has 10 years of service by April 1, 2015.

2.4 Similar Coverage – Means medical fringe benefits, which are substantially similar to the coverage provided by the Township.

2.5 Spouse - Means the person to whom participant has been married or life partner for at least 6 years prior to the date of termination of the full time continuous service of the participant, subject to the terms of the insurance contract.

2.6 Township - Means the Township of Thetford.

2.7 Employee Years of Full Time Service – Means any year during which an employee has been employed by the township for at least 1820 hours.

Article III - Eligibility for Employees and Elected Officials

3.1 To be eligible for the continuation of medical fringe benefits from the township, an Elected Official must:

Have at least 10 continuous years of full time service as of April 1, 2015.

3.2 To be eligible for the continuation of medical fringe benefits from the township, an Employee must:

- A. Have accumulated at least 75 points as determined by paragraph 3.3 at the time of termination of his/her service with the Township; and
- B. Have accumulated at least 65 points as determined by paragraph 3.3 to receive 50% of the medical fringe benefits available at the time of the termination of his/her service at the township, and
- C. Not have similar medical fringe benefits available from a spouse or an employer of a spouse without change to the Participant, and
- D. Not been terminated for cause; and
- E. Not been convicted of a crime related to the participants' service with the Township.

3.3 Points are accumulated by an Employee as follows:

- A. An employee shall be given one point for each year of age
- B. An employee shall be given one point for each year of continuous full time service.

All other provisions of previous Ordinance 94, adopted 2-9-1998 shall remain effective and are hereby reincorporated into this Ordinance by reference.

#### Invalidity

If any section, paragraph, sentence, clause, phrase, or part of the Ordinance is declared invalid for any reason whatsoever, such a decision shall not affect the remaining portions of the Ordinance which shall remain in full force and effect and the provisions of the Ordinance are hereby declared severable.

## Effective Date

This Ordinance shall take effect 30 days after the first publication of the Ordinance.
