#### **PRESENTATIONS:**

Genesee County Treasurer Deb Cherry came in to talk to the board and the residents regarding the steps on foreclosed properties. She gave the Clerk some applications for residents who have not paid there 2013 taxes yet to be able to work out a payment plan to keep their homes. She stated that there are 2000 properties a year which come into the program. Once the house is taken, it will go up for auction in September on back taxes, 2<sup>nd</sup> auction in October with no minimum bid, if not sold then it will be offered to the township to see if they would like to take it. If property is not sold or taken by the township it will then go to the land bank, 25% of all the housing in the City of Flint is owned by Land Bank. If anyone would like to look at any Land Bank houses or land, you can go to their web site at www.thelandbank.org. Genesee County Treasurer's office will work with the tenant when the landlord refuses to pay the property taxes.

Fund balance as of February 18, 2016: \$394,125.12

- On February 10, 2016, Governor Snyder, in his 2016-17 fiscal year budget recommendation, called for \$10 million from the General Fund to go towards new election equipment, to be matched with \$5 million in local funds. He also said Michigan still has \$25 million in Help America Vote Act funds remaining to aide new equipment purchases. So I will be budgeting \$10,000 in this year's budget for Thetford's share for the new election equipment.
