Trustee Gunnels explained it was about her. Clerk Pennington withdrew her motion and advised Supervisor Stevens to table this until we have an attorney present. Treasurer Ayotte went to get a copy of The Open Meetings Act, with much discussion Trustee Congdon withdrew his support, therefore, the board did not go into closed session.

Brief Public Comments

Public comments began at 7:45 p.m Ended at 8:00 p.m. Nine comments were received.

• The only reason I am raising this now is because this township has been notified that I am appealing this lawsuit. If matters because it seems to be this invisible barricade that prevents us from settling this case. I would like to know what the barricade is, what is preventing us to settle this case. The appeals goes on, how much more is it going to cost the township. We have already cost the township \$65,000, just had to approve a new figure to cover the cost. So at what point does the elected officials have a say so on the money and how it is spent.

Supervisor Stevens ~ I would like to offer an opinion, I would really like to discuss it with you in my office tomorrow morning or Wednesday morning. In my opinion once it reaches the courts this board is discharged from settling.

There is no point for me to go tomorrow to the settling if you have no intention on settling. If this board has no intentionally in settling we will go all the way to Supreme Court. How much money do you have?

Clerk Pennington ~ this needs to stop

Supervisor Stevens ~ point of order

Clerk Pennington ~ can I clarify something? That extra \$3,300.00 that he is saying that cost the township more in his lawsuit. That money was to amend that budget line because we didn't budget enough. The money was already spent it is not any additional money

- Minutes have greatly improved, I look at them on reference often
- Congrats to the new board, great turn out for the November Election, whenever they will do road chloride the road foreman will call you Supervisor Stevens, Closed session, Attorneys we have a township attorney, prosecutor attorney and the insurance company would not take the case is why we had to get another one involved because the person was not asking for money, Supervisor Stevens you in the Herald said you were going to have a budget workshop could you please make sure you post it on the web site and facebook I really would like to attend. Thanked the new board again
- Would like to see the board have name plates, would like events made on the facebook to remind the residents that there is a meeting.

Supervisor Stevens ~ we are working on getting the agenda on the web site. So the residents will know ahead of time what's going to happen at the meeting

- Thanked former Supervisor Eileen Kerr for her time that she served Thetford Township
- Congrats to the new board
- Pending court matter usually people involved abstain on decision making that they are involved with.
- There is no greater agony then to bearing untold stories. I cannot express on how much agony I have over this lawsuit. "Error doesn't become a mistake unless you refuse to correct it." That statement cannot be truer, there is an effort here to resolve an issue for three years. I don't know why. If it was you Chair sitting in these position or someone else I would still be here doing the same exact thing I am doing now, appealing this form of our nation's democracy. I am here to get my justice. I feel that has been aborted in a sick and disgusting way. That I have been put out by the people who did this to me. Those people need to be questioned for what they did. I want a further investigation internally to our departments, employees and elected officials. I am fed up with the courts. I am here because I have an unresolved issue. I was hoping that we would get some movement on this matter, there is a lot of decisions that I have to make, have to do with your decision tonight. The fact in the matter I have decided actually your insurance company has decided to settle this case. They want to settle then settle, money damages then let's talk money damages. But if your insurance company is just going to give me the run around like they did last time, in my opinion just a sick joke anyone with an ounce of brains could look at the material I have right in front of me and determine on what happened on February 12, 2014 and as I said in the herald this judge is corrupt or blind or what. I am not cowering down to anyone. I have tried to be nice, I have tried to be professional and I tried to do things properly with the limitations. To be honest with you, looking back I would have done it a whole lot differently. I would have done here on this podium if I knew it would have taken it this long to get where we are right now with no results in sight. There is no end sight in this. And this township is going to spend thousands and thousands dollars to defend a frivolous warrant that has no more merit or authority then a piece of toilet paper in a toilet tank.

Supervisor Stevens ~ at this point you are running way over the 3 minutes, I don't mind if you do my time but the residents didn't come here on this kind of matter. Basically the court has made a decision and we have to abide by it. We don't always like what we here.

You are someone on this board should call the insurance company and get them to settle. You have spent \$65,000 dollars of your money. You cannot settle in that.

Supervisor Stevens ~ I will put that under advisement and there are a lot of opinions that are related to this and not all opinions are always the best. At some point the insurance company comes to us and tells us what needs to be done. At this time it is not any of our decisions you either have to appeal it with the courts or it's gone, it's done. I don't always believe it's the right answer but at some point you have to stop on what's going on and move on.

This is one of those things, I will not take no for an answer. This is one of those things, I will not let it go.

Supervisor Stevens ~ and that's your right, and we need to have our discussion at a different place.

When can we have this discussion?

Supervisor Stevens ~ tomorrow morning, Wednesday morning any morning you can be here.

 Back when you all were running, we talked about wrapping up this Eric thing and everyone agreed. Where you all by each other. Let's get this wrapped up for Eric.

Supervisor Stevens ~ direct your comments to the chair, our job is not to hand money out to anyone who has a law suit. That's why there are courts, attorneys and procedures. I wish we had enormous bank accounts so we could do that but we don't and we won't.
