CLERK'S REPORT:

We had an Election Commission meeting on October 21st on combining Precinct 1 and 5 together to create one precinct. The new precinct would vote at Lacure Elementary and be called Precinct 1. The reason for this change is due to the poor conditions of North Morris's Club House.

Doesn't look like we will be getting new voting systems for the 2016 election. But talks are still going on. The current system that we are using was purchased 100% by Help America Vote Act. The next system HAVA will only fund 50%, so the 2016 budget I will have to budget \$2,000.00 a precinct which will be \$10,000.00 to be set aside for the purchase of the new voting systems.

Special Assessments ~ The Township has historically had special assessments for garbage and streetlights. Similar to property taxes, special assessments are recognized when measurable and available. Any unavailable/unearned amounts are reported as deferred inflows/liability and a receivable is set up. For service type assessments, in the government-wide statements, revenue is recognized when the services are provided (in other words, when the exchange takes place). Since the services type assessments are all billed annually in the period to which the assessment applies, the revenue is recognized during that fiscal year. Again, in the modified accrual fund, revenue recognition is subject to the period of availability:

So the revenue collected each year is already earned and recognized when collected. It is not for the following fiscal year.
